Amendment to Hackney Carriage Vehicle Licence Advertising Conditions

(Environmental Scrutiny Committee – Executive Councillor: Councillor Mrs Holland)

A Part I Public Agenda Item

1. Purpose of Report

1.1 Members are invited to consider proposed amendments to the Hackney Carriage Vehicle Licence Conditions to permit illuminated advertising to be placed on the roof of a taxi.

2. Recommendation

2.1 Members are invited to consider:

- (a) An amendment to Hackney Carriage Vehicle Licence Condition 3.d) to add the words 'or roof of the vehicle provided that advert does not exceed 665mm x 95mm x 450mm (26" x 4" x 17") on a saloon car and 1044mm x 95mm x 360mm (41" x 4" x 14") on an estate car or purpose built cab.'
- (b) An amendment to Hackney Carriage Vehicle Licence Condition 3.h) to add the words 'and provided that no other advertisement appears on the said roof.'

3. Background

- 3.1 In July 2003, a request was received from Mr Paul Sutton of the Southend Taxi Drivers Association proposing that illuminated advertising be allowed on the roof of a taxi. An informal viewing of the proposed sign by the Licensing Committee took place on 30 June 2003. In his letter dated 30 July 2003, Mr Sutton asks to put before Committee a full presentation regarding the advertising.
- 3.2 Taxis displaying the two sizes of advertising will be available for Members to view prior to the Committee meeting.
- 3.3 **Appendix 2** contains a copy of the Council's current Hackney Carriage Vehicle Licence Conditions.

4. Proposal

- 4.1 It is proposed that Licence Conditions 3.d) and 3.h) are amended to permit such advertising, as shown at Recommendation 2.1.
- 4.2 The proposed amendments relate only to Hackney Carriage Conditions of Licence.
