In depth Scrutiny projects – 2015 / 16 A Part 1 Agenda Item

1. Purpose of Report

- 1.1 For each Scrutiny Committee to agree the in depth scrutiny project to be undertaken in the 2015 / 16 Municipal Year.
- 1.2 The report also attaches some information about the work carried out by each of the Scrutiny Committees in the 2014 / 15 Municipal Year.

2. Recommendations

- 2.1 That each Scrutiny Committee select the topic it wishes to undertake for in-depth study in 2015/16.
- 2.2 To note the information attached at <u>Appendix 3</u>, the summary of work of the 3 Scrutiny Committees during 2014 / 2015.

3. In depth scrutiny projects

- 3.1 Involvement with in-depth studies enables Members to 'get their teeth into' a particular topic and also to influence and shape proposals before they are implemented.
- 3.2 Each of the studies are led by a Member project team / programme working party and the appointments were agreed at Council on 21st May 2015 (refer to <u>Appendix 1</u>).
- 3.3 Members should always aim to select a topic which can identify real service improvements and results in benefits / outcomes. To assist the Committees in selected a topic for this Municipal Year, a list of previous topics undertaken for in depth study since 2008 is attached at <u>Appendix 2.</u>
- 3.4 Some of the recent reviews have been on how plan to meet the growing demand for social rented housing and impact of welfare changes. There are numerous positive outcomes from scrutiny taking an in-depth look at an issue. An example of this is the project 'Developing strong partnership links to encourage investment in the town and the supply of employment opportunity in 2012 / 13. One of the

key recommendations was the development of a Southend Skills Strategy and this was agreed by the Council in November 2013¹.

- 3.4 The following topics have been suggested to date for in depth study in 2015/16:
 - (a) Place Scrutiny Committee A127 Improvements and Route Management strategy.
 - (a) People Scrutiny Committee Transition arrangements from children to adult services.
 - (b) Policy & Resources Scrutiny Committee Control of personal debt and the advantages of employment.
- 3.5 Supporting information on each of the suggested projects will be reported verbally at the relevant Scrutiny Committee meeting.
- 3.6 <u>Work undertaken by each of the Scrutiny Committees in the 2014 / 15</u> attached at <u>Appendix 3</u> is a summary of the work undertaken by each of the Scrutiny Committees in the 14/15 Municipal Year.
