Work programme 2014/2015 - evaluation

During the 2014/15 Municipal Year, the **Policy & Resources Scrutiny Committee** held **6** meetings and met on the following dates – 16th July 2014, 16th October 2014, 20th November 2014 (special), 4th December 2014, 29th January 2015 and 16th April 2015.

During the year, Members undertook the following scrutiny work:-

<u>Call-ins/ references from Cabinet</u> – the Scrutiny Committee considered **2 call-in items** from Cabinet. No items were called in from the Forward Plan. At the July meeting **10 items** were **referred direct** to the Scrutiny Cttee (due to there being insufficient time for call in period). At the special meeting on 20th November 2014, **1 item** was **referred direct** to the Scrutiny Cttee. All budget items were **referred direct** to the Scrutiny Committee and considered at the meeting in January 2015 (**9 items**).

<u>Pre Cabinet items</u> – the Scrutiny Committee considered 1 pre Cabinet item (a) Universal Credit – 4th December 2014.

- Minutes of the meetings of the Chairmen's Scrutiny Forum held on 4th November 2014 (reported to December meeting) and 30th March 2015 (reported to April meeting).
