- (b) There is demonstrable evidence through accident analysis that there have been at least 3 personal injury accidents during the last three years resulting from adverse and/or indiscriminate parking in the vicinity.
- (c) Waiting and loading restrictions may not be introduced in isolated residential streets unless there are pedestrian and traffic safety issues demonstrated through the accident statistics (as in (b) above).
- (d) Where high traffic volume and flow is affected by parked vehicles.
- (e) at a junction (agreed Jan 13)

13/37	November 13	Cllr D Garston	Implement waiting restrictions to deter commuter parking. Barnstaple Close and Broadclyst Close	Does not meet criteria, Footway parking occurring which is obstructive and narrow entry roads into these closes is not wide enough to accommodate any parking.
13/38	Nov 13	Cllr Crystall	Consider residents parking permits for Laurel Close. Residents have surveyed neighbours and 27 of 32 properties support permit style parking.	While very well supported, any parking controls should be implemented on an area wide basis to avoid displacing vehicles and reacting on a piecemeal basis to issues.
