Work Programme 2013/2014 - Evaluation

During the 2013/14 Municipal Year, the **Place Scrutiny Committee** held **7** meetings and met on the following dates – 8th July 2013, 7th October 2013, 16th October 2013, 25th November 2013, 27th January 2014, 17th February 2014 and 7th April 2014.

Members undertook the following scrutiny work:-

<u>Call-ins/ references from Cabinet</u> – the Scrutiny Committee considered **27 call-in items** and **3 items referred direct** from Cabinet/Cabinet Committee. No items were called in from the Forward Plan. All budget items were referred direct to the Scrutiny Committee and considered at the meeting on 27th January 2014 (4 items).

Pre Cabinet items – the Scrutiny Committee considered 5 pre Cabinet items:

- Review of Victoria Gateway Scheme 7th October 2013
- Southend Foreshore Fisheries 7th October 2013
