- 3.3 Involvement with the in-depth studies enables Members to 'get their teeth into' a particular topic and also to influence and shape proposals before they are implemented. Members should therefore aim to select a topic which can identify real service improvements.
- 3.4 Each of the studies are led by a Member project team / programme working party the appointments were agreed at Council on 16th May 2013 and the membership is set out at **Appendix 1**. To assist the Committees in selected a topic, a list of previous topics undertaken for in depth study is attached at **Appendix 2**.
