In depth scrutiny report –
The Council's community leadership role in promoting safer communities
A Part 1 Agenda Item

1. Purpose of Report

To seek formal approval to the draft report of the scrutiny project – 'The Council's community leadership role in promoting safer communities'.

2. Recommendations

- 2.1 That the report and the recommendations from the in depth scrutiny project attached at Appendix1 be agreed.
- 2.2 That the Chairman of the Project Team be authorised to agree any final minor / typographical changes to the draft report.
- 2.3 That in accordance with Scrutiny Procedure Rule 10 (Part 4 (e) of the Constitution), to agree that the Chairman of the Project Team present the final report to a future Cabinet meeting.

3. Background

- 3.1 The Policy & Resources Scrutiny Committee selected its topic at the meeting on 16th July 2014 (Minute 134 refers). The project plan was agreed by the Project Team and then the Scrutiny Committee on 16th October 2014 (Minute 302 refers) with the following objectives:
 - the role of the Council in promoting safer communities;
 - the role the Community Safety Partnership and partner bodies play in this agenda;
 - the changing landscape with the Essex wide Police & Crime Commissioner; types of crime / performance;
 - the existing / changing arrangements for engaging with local communities; and
 - review the impact of partnership activity with aim to provide reassurance there is effective engagement with local communities.
- 3.2 The Member Project Team, which was Chaired by Councillor Habermel, met on 3 occasions and held a full day of evidence gathering with invited witnesses in February 2015. The focus of the event was on the following:-
 - > the 'big issues' of (a) violent crime and (b) prolific offender management; and
 - > the 'local issues' / concerns around cycling on pavement.

3.3 These areas were identified as they reflect some of the current issues that both Southend Borough Council and Southend Community Safety Partnership (CSP) are addressing or potentially, require further support or work to address.

4 Recommendations

- 4.1 The draft scrutiny report is now attached at <u>Appendix 1</u>. The report has been discussed by the project team and will be shared with the witnesses. It should be noted that approval of any recommendations with budget implications will require consideration as part of future years' budget processes prior to implementation.
- 4.2 Scrutiny is recommended to endorse the following recommendations, which link to the agreed project plan and the proposed outcomes from the project, as set out at Section 5 of **Appendix 1**, for approval by Cabinet:
 - (a) That the Cabinet consider the in depth scrutiny report on the Councils community leadership role in promoting safer communities and agree the conclusions from the study.
 - (b) That the Community Safety Partnership (CSP) develop an action plan of delivery, detailing specific actions to take forward the key conclusions from the review for agreement and for implementation.
 - (c) That the CSP to monitor the Action Plan outcomes and provide feedback on progress and report back to scrutiny in 12 months.
