School Admissions Arrangements for Community Schools 2014/15 Executive Councillor: Councillor James Courtenay A Part 1 Public Agenda Item

1. Purpose of Report

- 1.1 To report the outcome of consultations with schools on the school admission arrangements and the proposed recommendations to Cabinet on 19th March 2013.
- 2. Recommendation
- 2.1 That the Committee's views are sought.
- 3. Background
- 3.1 Children and Learning Scrutiny Committee on 26th November 2012 considered the Cabinet report of 6th November 2012 on the School Admission Arrangements for Community Schools.
- 3.2 The proposed published admission numbers were sent to community schools and the closing date for any comments was 10th January 2013. The only changes to the agreed published admission numbers from September 2013 to September 2014 are proposals to increase Thorpe Greenways Infant School from 120 to150 and Darlinghurst Primary School from 90 to 120. For all other community schools the published admission number (PAN) remains unchanged from 2013/14.
- 3.3 The Governing Body of the Federation of Greenways Schools confirmed agreement to an increase to 150 subject to the provision of additional accommodation. There has been no specific comment from the Governing Body of Darlinghurst Primary School although an initial agreement of the Governing Body, through the Headteacher in October 2012, with officers was also subject to accommodation issues. Capital funding for additional accommodation at both schools is identified in the draft capital budget for 2013/14 elsewhere in the agenda.
- 3.4 No other comments were received from Community schools by the closing date.
 A list of the proposed PAN's for community schools for 2014/15 is in Appendix 1.
- 3.6 Academy, Foundation and Voluntary Aided schools are responsible for determining their own admission arrangements and admission numbers.

Changes in regulations only require consultation if there have been changes in arrangements from the previous year or once every seven years. The consultation period ends on 28th February 2013 and determination of the arrangements by schools has to be made by 15th April 2013.

- 3.7 Cecil Jones are proposing to reduce the PAN from 280 to 190 and at the time of writing there have not been any other proposed changes to published admission numbers. A list of the determined PAN for 2013 for Academy, Foundation and Voluntary Aided schools is attached at Appendix 2 for information.
- 3.8 It is proposed to recommend the published admission numbers for community schools as set out in Appendix 1 to Cabinet for approval.

- 5.1 Contribution to Council's Vision & Corporate Priorities These arrangements will assist pupils within the Borough to access to quality learning opportunities to achieve the best possible outcomes for all children.
- 5.2 Financial Implications Capital funds to expand at Thorpe Greenways and Darlinghurst schools are identified in the Draft Capital Programme 2013/14 elsewhere in the agenda. There are no direct revenue implications for the Council. The administration of school admissions is funded from the Dedicated Schools Grant.
