Petition Received

Maldon Road and Milton Street - Traffic Volume, Speed and Parking Problems.

A Part 1 Public Agenda Item

1. Purpose of Report

1.1 To advise the Working Party of a petition received since the meeting of 6 November 2008.

2. Recommendation

2.1 That the substance of the petition is noted and that, if necessary, further consideration is given by the Traffic and Parking Working Party when the matters raised by the petition have been investigated by Officers in the context of the Councils Local Transport Plan and other Strategies as appropriate.

3 Background

1.1 The petition is presented on behalf of the residents of Milton Street and numbers 1 to 13 Maldon Road and has been signed by 28 residents of 24 addresses in the local area as follows:-

Milton Street 15 addresses, Maldon Road 5, Short Street 3 and Milton Close 1.

- 1.2 The petition reports, in a general way, problems which "make daily living for local residents very difficult and challenging" as follows:
 - Insufficient parking in the street mainly due to yellow lines.
 - Commuter parking.
 - Parking attendant activity residents ticketed while unloading their vehicles.
 - House multi-occupation flat conversions.
 - Large vehicles using the road to access Greyhound Industrial Area.

- Damage (sometimes serious) to parked vehicles by the above large vehicles.
- Inadequate road space for large vehicles to manoeuvre.
- 1.3 The petition continues, putting forward some possible solutions:
 - Removal of yellow lines.
 - One-way street.
 - 20 mph speed limit.
 - Controlled Parking Zone with permits for residents only.
 - Permitted footway parking (to be clarified).
- 1.4 Attached to the petition are copies of three letters dated 2002 which indicate that residents made representations in support of a controlled parking zone at that time.
- 1.5 Also attached to the petition are 8 photographs illustrating some of the problems reported by the petition.

4 Corporate Implications
