1. Purpose of Report

To provide an update on progress of Member's Requests for parking, crossing, speed and road safety schemes as listed in **Appendix 1**.

3. Background

This report is an update on the report, which went to Traffic & Parking Working Party & Cabinet Committee on 15th June 2009. This report is working towards prioritisation of the councillor's requests.

4. Corporate Implications

4.1 Contribution to Council's Vision & Corporate Priorities:

Once developed and implemented these can have an impact on Customer Satisfaction by reducing concerns about road safety, parking and improve the environment and street scene.

4.2 Financial Implications

An estimated sum of £5,000 is to be spent from the LTP programme to cover the cost of Pedestrian counts at Cambridge Road (Ref C9), Western Approaches (Ref C10), Manners Way (Ref C13) and Eastwood Road (Ref C14). Consultation at Montague Court (Ref M2), pedestrian drop crossing at The Bell (Ref M8) and a street name board at Repton Grove (Ref M11).

4.3 Legal Implications

Implementation of some schemes will require Traffic Regulation Orders and Notices, which will follow the statutory legal processes.

4.4 People Implications

The work to implement these schemes can be met within existing staff resources or supported by the Council's term contractor for highway works.

4.6 Consultation

Most schemes will involve informal and formal consultation.

4.7 Equalities and Diversity Implications

The proposals for all schemes will consider those with physical mobility limitations and make improvements for those with visual impairments as far as possible.

All work will be designed in house or with the use of term consultants and implemented by term contractors. All contracts have been tendered in competition and in accordance with Procurement Guidelines and demonstrate value for money.
