1. Purpose of Report

For the Traffic and Parking Working Party and Cabinet Committee to consider details of the objections to recently advertised proposals for introducing parking charges along eastern seafront area from Victoria Road to Thorpe Hall Avenue and make an appropriate decision.

2. Recommendation

 - 2.2.2 Implement the scheme with amendments, or
 - 2.2.3 Take no further action

In the event of either 2.2.1 or 2.2.2 being agreed to authorise the implementation of the scheme as advertised, or amend to reduce the impact, as appropriate.

3. Background

3.1 On street controlled parking provision in the form of signs and lines requires regular maintenance generally funded through revenue budgets. Enforcement costs of any restrictions is also funded through our revenue accounts.

- 3.2 Reductions to budgets requires that additional income is generated to contribute to these costs, income from Penalty Charge Notices (PCN'S) issued to vehicles contravening restrictions cannot be considered as maintenance funding as our target is to achieve full compliance of all restrictions resulting in zero issue of PCN's therefore additional income must be generated.
- 3.3 The eastern seafront area from Victoria Road to Thorpe Hall Avenue has on street parking provision for which no charges currently apply and is inconsistent with the adjoining parking charges. Parking facilities adjacent to Southend East Station are also currently free of charge. levying charges in these areas contributes to the overall maintenance and enforcement costs of the boroughs parking and waiting restrictions but also brings these areas in line with nearby facilities for which charges are payable.
- 3.4 It also needs to be noted that Members agreed through the 2011/12 budget process to propose charges in these areas.
- 3.5 Proposals to implement this decision were advertised in March 2011 and resulted in the objections detailed in Appendix 1 to this report.

5. Reasons for Recommendations

To achieve appropriate maintenance and enforcement self funded by on street parking income.

Controlling parking improves safety and ensures businesses have adequate turnover of customers able to park near to their business.
