1. Purpose of Report

For the Traffic and Parking Working Party and the Cabinet Committee to consider a request to remove a maximum of 4 parking bays in Alexandra Street outside of the proposed learning disability day centre (currently the South Essex Homes offices) and replace the bays with a bus stand operational during the opening hours of the day centre

2. Recommendation

- 2.1 That the Traffic and Parking Working Party note the proposals.
- 2.2 That the Cabinet Committee approves the advertisement of the removal of the parking bays at the location detailed above and further agree that in the event of there being no unresolved objections to the proposals, the Traffic Regulation Order be confirmed and a dedicated bus stand. Any unresolved objections will be referred to a future meeting of the Traffic & Parking Working Party and Cabinet Committee for consideration.

3. Background

- 3.1 South Essex Homes are relocating and a new day centre is being created for our residents with learning disabilities. The services will be accessed by some clients via our own transport service and parking close to the entrance is vital for those who have mobility difficulties and rely on our transport.
- 3.2 It is requested that the existing parking bays be removed and replaced with a Bus Stand to facilitate access.

3.3 We have recently improved the layout of the parking bays in Alexandra Street resulting in an additional 3 bays being provided, this proposal will therefore result in a net loss of 1 parking space.
