25	July 12	Clir Longley	Broomfield Avenue – Request for traffic calming due to volume & speed of vehicles. One particular resident is having their property damaged by vehicles that leave the road. As such accidents do not often involve injuries, these do not appear on the accident database.	From the speed data, it would appear there is a speeding problem with nearly 20% of vehicle exceeding the limit in one direction and 16% overall. Broomfield Avenue does have 5 accidents along its full length which is 350m. 2 of these involved serious injuries and 3 slight. 1 involved a child as a pedestrian who suffered serious injuries. I understand there are a number of non injury accidents occurring that involve damage to one or two particular properties. Traffic calming suggested and has been added to project list for prioritisation.
26	July 12	Clir Adam Jones	Wells Avenue - Vehicles parking for up to 2 weeks due to the airport whilst airport customers are going on holiday. This is causing safety and personal care issues. Safety as at times vehicles are left leaving narrow gaps that emergency vehicles such as fire appliances and ambulances may have difficulty getting through. Personal care issues as the resident has daily care and it is proving difficult for her carers to park near to her property due to the number of holiday makers vehicles	Area surrounding the airport is subject to monitoring and possible PMS funded by airport if increase of parking evidenced. Initial monitoring Dec 11, repeat to be undertaken in the near future. Inadvisable to focus on individual streets as any parking will be displaced, an area wide action should be implemented. Recommend no action at this time but ongoing monitoring to continue within the spirit of the S106.
