3. Background

- 3.1 A special meeting of the Council was held on 30 July 2020 to consider the Cabinet's proposal to support a collaboration with South Essex Authorities to deliver regeneration across South Essex and to note the intention of ASELA (the Association of South Essex Local Authorities) to immediately engage with Central Government to start negotiations. The Council noted the Cabinet's decision (minute 185 refers).
- 3.2 At the Council meeting on 30 July 2020 referred to in 3.1, the Leader stated that he was prepared to establish a Working Party to have oversight of the on-going work of ASELA and issues coming from the forthcoming White Paper on Devolution.
- 3.3 An informal meeting of this proposed Working Party was held on 2 September 2020, to ensure councillor involvement was not delayed. Prior to this informal meeting, two Councillor Briefing Sessions were held on 26 and 27 August 2020.

3.4 The purpose of this report is for the Council to formally establish the ASELA and Local Government Reform Working Party with the terms of reference set out in **Appendix 1.**

These terms of reference were endorsed at the informal meeting referred to in 3.3 above.

If this is agreed, the terms of reference will be added to Part 2 of Schedule 3 to the Constitution.
