These 76 interviews relate to 39 children, 5 of which are Southend LAC placed outside of Southend. There have been 24 children, with 48 missing episodes, where the RHI was not successful; either the child was not seen, the child refused the visit or the visit was unable to take place, with 16 of these relating to Essex LAC placed in Southend. As at 6th January, 1 child is currently missing. Essex Police have changed their policy around missing children in recent months, as a result children will no longer be classed as 'absent' and all children will now be classed as 'missing'. As such, this change in policy will have (and has had) an ongoing significant impact on the number of children reported missing and therefore the number of children requiring a Return to Home Interview. Also within this crime category is a change in national crime recording rules which means that Malicious Communications is now recorded as a crime. About 70 such offences have been recorded this year that would not have been recorded last year.
