Schools and High Needs Funding Reform

1 Purpose of Report

The Department for Education has recently launched consultations around the Schools National Funding Formula and the High Needs National Funding Formula. These consultations have a significant impact on mainstream schools, special schools, and the PRU. This change has been long awaited and it is important that all affected contribute to the consultation response.

2 Recommendation

Education Board is asked to;

- 2.1 Consider any key issues that they want to be taken into account in the Local Authority's response to the consultations and whether to;
 - 2.1.1 form a short life sub-group of the Board to assist in the response to the Schools National Funding Formula consultation;
 - 2.1.2 use the existing SEND Strategic Board to assist in the response to the High Needs Funding Reform consultation; and
- 2.2 Disseminate information about the consultation process through their networks, professional associations, partnerships and other channels to encourage all those affected to reply directly.

3 Background

3.1 Two consultations were launched by the DfE on 14th December, one on a schools national funding formula and one on high needs national funding

formula and other reforms. Both are available from:

3.2 Both consultations have a closing date of 22nd March 2017.

4 The Proposals

National Funding Formula for Schools

- 4.1 As expected the Schools consultation sets out proposals for a single national funding formula that will be used to calculate all school's budgets. This is similar in structure to the current formula and will be based on:
 - A basic level of per pupil funding,
 - Additional needs funding for deprivation, low prior attainment, EAL and mobility,
 - School led funding, with a lump sum, sparsity, premises costs and a growth funding mechanism,
 - Geographic funding through an area cost adjustment.
 - This stage of the consultation focuses on the relative weightings and values of the various formula factors.
- 4.2 Schools budgets will be set on the current basis in 2017/18, a 'soft' national formula will be used in 2018/19 with some local discretion but the schools block will be ring-fenced, and a 'hard' national formula will be used in 2019/20 with very limited local discretion, in areas such as growth funds.
- 4.3 Transitional arrangements will limit the loss of funding per pupil per year to 1.5% and the loss of funding overall to 3% per pupil.
- 4.4 These proposals are complex and will need some considerable analysis to fully understand the implications for Southend-on-Sea. **Overall illustrative figures show a decrease in funding of 2.56%**, which must also be taken in the context of numerous years with no inflationary funding whatsoever. Appendix 1 shows the illustrative impact of the Government's proposals.
- The national proposals will also have the effect of changing Southend's primary to secondary ratio from 1:1.32 to 1:1.29.
- 4.6 The key issues that we must work through and address in our response to the consultation include:
 - The impact on schools every school is modelled to lose funding from the new formula.
 - How baselines for schools will be calculated
 - Whether the current transfer between the schools block and early years block will continue to be honoured, and if not the implications for early years
 - The impact on LA central statutory functions and how these will be funded in future

- The persistent issue that the Area Cost Adjustment for Southend-on-Sea does not reflect actual cost pressures experienced by Schools and the Council
- How in practice the arrangements for growth will work
- 4.7 It is suggested that the Education Board convene a short life sub-group of representatives of Academies and Maintained schools to assist the Council in producing a response to the consultation. Individual schools of course can submit their own responses.

High Needs

- 4.8 Proposals for High Needs Funding are different in that there is no proposal for direct funding of special schools or the PRU through a national formula but instead for Local Authorities to be funded on a formula basis that would replace the current historic allocations.
- 4.9 This formula would be based on the following:
 - Population 2 to 18
 - Deprivation factors
 - Low attainment factors
 - · Health and disability factors
 - Area cost adjustments
 - A factor to reflect the current level of the High Needs Block in each Local Authority.
- 4.10 The new formula will take effect in 2018/19, but there will be transitional arrangements in place so no authority loses any funding. This will slow down the pace of change and so any gain to Southend-on-Sea will take several years to be realised. We expect to gain by approximately 8.8%, worth about £1.5 million, should the proposals be implemented. However, this will be phased over several years; we would expect to gain by no more than £0.4 million in 2018/19.
- 4.11 We believe the key issues raised by this consultation include:
 - The slow pace of change, with too much funding locked in at current levels, thus penalising authorities such as Southend-on-Sea which have historically low allocations
 - The total quantum of funding will not be sufficient to meet needs in Southend-on-Sea, as these are growing rapidly and the pace of funding growth is slow
 - As with the School Formula proposals, the persistent issue that the Area Cost Adjustment for Southend-on-Sea does not reflect actual cost pressures experienced by Schools and the Council
 - How the baseline is calculated
 - Our ability to change current funding arrangements for providers to ensure differentials are justified and all funding can be used efficiently to meet the needs of pupils

- No clear commitment to when full transition to the new funding formula will be achieved for those authorities who do not reach their new formula funding levels during the current parliament
- 4.12 It is suggested that the Education Board may wish to use the existing SEND Strategic Board to assist the Council in producing a response to the consultation. Individual schools of course can submit their own responses.
