1 Apologies for Absence

Apologies for absence were received from Councillors Betson, Evans, Davies and Borton (no substitutes). Apologies also received from Ms S Hart and Ms P Draycott.

2 Declarations of Interest

There were no declarations of interest at this meeting.

3 Minutes of the meeting held on 8th June 2015 and Matters Arising

Matters Arising

3.1 Review of Members Item 4.1 refers) – The Clerk and Advisor reported that they had undertaken a detailed review of the membership and had resolved a number of vacancies. There were still some vacancies to fill, namely in the Group C category, Associations Representing Teachers. The Clerk and Advisor would continue to monitor and where possible fill the current vacancies. Mr T B Singh was identified as a possible Sikh representative.

In respect of teacher representative it was suggested that to widen the participation of teachers the SACRE meetings could move to later in the day, e.g. starting at 4pm instead of the current 2/2.30pm time. It was AGREED that the summer term meeting be held at 4pm, to allow teachers (and others) to attend.

<u>3.2 Update on work with schools (item 8 refers)</u> – The SACRE was informed that the RE teacher training day organised by REToday held on 23rd June 2015 was well received by teachers and had supported them with a wider understanding of RE, particular those teachers who were not RE specialists.

Further ReToday teacher training would be arranged, subject to available funding. It was suggested that the SACRE use some of its budget to support the training.

(c) National Developments in RE (Item 9 refers)

The changes to the examination criteria for RE GCSE and A-Level were referred to. The changes/new criteria have put a stronger emphasis on comparative religion.

It was suggested that the Inter-Faith Forum could provide some support on comparative religion. AGREED that Mr B Maddison, Frances Neil, Dr N Kokha and Ms K Mistry could produce some learning information on comparative religion for use in schools/by teachers.

The SACRE also discussed the recent High Court ruling concerning the application of humanism to collective worship. It was noted that although the SACRE need to be aware of the ruling it currently has no substance in legislation/law and it is understood that the Government had appealed against the ruling.

(d) GCSE and A-Level Results

The SACRE was informed that it was their responsibility to collect the data on the RE GCSE and A-Level results and review how the RE Syllabus was working within schools. The SACRE were also responsible for considering any determinations put to it either by the Local Authority or the school.

AGREED: Frances Neil to write to all schools in the borough requesting the GCSE and A-Level results (including Head Teachers, Heads of RE and the Chair of Governors) and a report be produced for SACRE on the results.

Resolved:

That the minutes of the meeting held on 8th June 2015 be confirmed as a correct record.

4 RETool - SACRE Self-Evaluation

The SACRE received the following documents:

(a) RETool Self-Evaluation

The SACRE considered the SACRE RETool reporting and evaluation toolkit which focuses on five key aspects of the work of the SACRE and is a tool to assist SACRE's identify areas of improvement and evaluate its work.

The SACRE made a number of comments and in general agreed that most areas identified in the self-evaluation tool were in the development category. A 2016/17 draft action plan had been produced which aims to address some of the key areas of development within the evaluation toolkit.

In respect to SACRE training (Section 2d of the evaluation toolkit) Frances Neil reported that there was an external trainer who could be brought in to provide training to the SACRE.

AGREED: Frances Neil to follow-up and engage the external trainer and a training session be arranged for the SACRE at its September 2016 meeting.

The SACRE made reference to the DFE guidance on collective worship regarding determinations. It was noted that the NATRE Executive had held a series of discussions on this issue, particularly around the potential move towards a national entitlement in RE. This was also being discussed by the RE Council. It was noted that national entitlement was a form of national curriculum for RE and could radically change the way RE was delivered in schools. Further details and progress would be reported back to future SACRE meetings.

(b) RE Advisor Progress Report

The SACRE considered a report from Frances Neil which provided an update on a number of areas that had been progressed since the last meeting.

The SACRE discussed the RE Schools Survey which had been commissioned by the RE Improvement Lead to gather information about RE and Collective Worship. The survey will be sent to all Head teachers, RE leads and school governor chairs. The deadline for survey returns would be end of February/beginning of March 2016.

AGREED: The survey to be sent to all schools in the borough and a report on the results of the survey be provided to a future meeting of the SACRE.

(c) RE CPD and Pupil Conference

The SACRE received details of the "Respect for All" RE CPD and Pupil Conference which will take place on Monday 7th March 2016 at the Leigh Baptist Church, Marguerite Drive, Leigh-on-Sea. The Conference is aimed at primary school teachers and Year 6 pupils. SACRE was asked if it could contribute some funding towards the conference.

Concerns were expressed that primary aged school children were not being taught/given the non-secular and humanist view in school. Assurances were given that this was not the case, although the non-secular / humanist view may be weaker in some primary schools than others.

AGREED: The Respect for All RE CPD and Pupil Conference be supported and a financial contribution of £230 be provided from the SACRE budget.

5 Review of the SACRE Constitution & Membership 2015/16

The SACRE considered a revised SACRE Constitution and Terms of Reference which had been updated in light of national and local changes.

In respect to the vacancies it was noted that where appropriate representation was not forthcoming from national and regional associations that the Clerk was approaching local groups, etc for representatives. It was suggested that this was referred to in the constitution.

AGREED: Adopted the revised Constitution and Terms of Reference, with the proviso about approaching local groups, etc where the national or regional organisation are unable to provide appropriate representation.

6 Draft Code of Conduct for SACRE Members

The SACRE considered a draft Code of Conduct for SACRE Members which had been produced by NASACRE.

AGREED: The Code of Conduct be adopted.

7 SACRE Members Handbook

The SACRE considered a reference handbook for SACRE Members which had been produced by NASACRE. The handbook was aimed at SACRE members, new or experienced and has been designed to help the SACRE become more effective. It also sets out the context and work of SACRE.

The SACRE discussed the handbook and suggested that it was used as part of an induction pack for all SACRE members.

AGREED: The Clerk to produce a SACRE Members induction pack.

8 NASACRE Conference and AGM 17th May 2016, Central Hall, Westminster, London

The SACRE was informed that the NASACRE Annual Conference and AGM was taking place on 17th May 2016 at the Central Hall, Westminster, London. Frances Neil will be attending with the Chair.

AGREED: Noted the details of the NASACRE Conference.

9 Any other business

(a) Certificate of Thanks

The SACRE AGREED that the pupils and teachers be presented with a certificate of appreciation for their guided tour and for allowing the SACRE to visit the school to hold its meeting.

Once again I am pleased to introduce the Annual Report on the work of the Southend-on-Sea SACRE. This has been a year of change with our previous RE Advisor retiring and a new Advisor taking over. It has been an exciting and rewarding time to be involved in Religious Education both locally and nationally.

The Borough' Agreed Syllabus, *Improving Learning Together in Religious Education*, is now well established within schools follow its launch in 2013. Feedback from schools is positive with teachers reporting that they value the flexibility in the syllabus that enables them to plan and deliver RE that is relevant to the contexts of their schools.

The Agreed Syllabus sets out to develop a range of skills and ideas including, reflection, empathy, creativity and the ability to engage in investigation, analysis, interpretation, evaluation and synthesis. SACRE believes that RE which is well taught can improve the wellbeing of all students and makes an important contribution to good community relations and to students' spiritual, moral, social and cultural development. By exploring questions of identity and community and helping young people to gain a deeper understanding about themselves and others it also promoting British Values, a key focus of the Department for Education. It is good to see that the network groups for primary and secondary teachers are flourishing.

Part of the SACRE's responsibility to support and monitor the provision of RE in the Borough's schools. RE is a statutory requirement for all children in full time education, under the provision of the 1944 Education Act. The analysis of GCSE results presented in this report highlights some considerable achievements but also evidence of underachievement.

Governors are reminded of their responsibility to ensure that RE is delivered in accordance with statutory requirements. SACRE also encourages a strong Spiritual, Moral, Social, and Cultural ethos to be evident within all our schools.

There continues to be a number of significant national reports published during the last year, all of which highlight the need for high quality training to enable teachers to teach RE that is engaging and effective. SACRE members have discussed and noted the issues raised in the reports and their implications for the Borough's schools.

I would like to acknowledge the support and guidance given to SACRE for a number of years by our Adviser, Janet Dyson, who has now retired. Janet has also supported the induction of a new RE Adviser, Frances Neil, in a handover period, which Frances and I much appreciated. Janet's contributions, particularly when writing and compiling the Borough's RE Syllabus, will continue to be supportive for all those in the Borough, teachers and learners together, whose Religious Education will be enriched through her work. On behalf of all members of SACRE, the Clerk, Robert Harris and Frances Neil I wish to thank Janet and wish her well in the future.

This report provides an overview of RE in the Borough's schools and the work of SACRE. I commend it to you.

1. Religious Education (RE)

1.1. STANDARDS IN RELIGIOUS EDUCATION

The SACRE continues to fulfil its responsibility to monitor standards and quality in RE, collective worship and spiritual development. Examination results at GCSE, A/S and A level are monitored as part of the Borough's overall monitoring and evaluation of standards.

Analysis of GCSE and A level results for 2015

There are *some* extremely impressive achievements in RS at GCSE and A level in some schools which must reflect the high quality of teaching. School entry policies for full GCSE Religious Studies (RS) differ from school to school, depending on the arrangements for statutory RE within the Key Stage 4 curriculum and the availability of RE within the school's Key Stage 4 option choices. Patterns of entry vary considerably between schools.

All Southend schools entered students for GCSE RS with cohort numbers ranging from 10 (11%), at Futures Academy to 178 (79%) at Cecil Jones College. Three schools entered close to 100% of students for the full GCSE. The comments on achievement that follow will clearly be affected by the overall patterns of entry. The selective nature of four of the academies and schools and their figures skew the borough figures somewhat and therefore comparisons must be considered with this in mind.

Achievement at GSCE Religious Studies

- 49% of students sat a GCSE course in Religious Studies which is slightly above the national figure of 44%
- Overall 76.4% of those pupils achieved A*-C grades at GSCE, which is above the national figure of 70.9%
- Six schools, exceeded this national picture significantly with students in three schools achieving 100% A*- C grades and one achieving 99.3%
- Achievement at the higher grades (A*/A) for GCSE RS, at 37.6% (= 15.8 + 21.8) is significantly above the corresponding national figures of 27.9% (= 9.7+18.2)
- These figures are equalled at Shoeburyness High, and are exceeded by St Bernard's and Belfairs, and exceeded significantly so in the four 'selective' schools/academies
- At Westcliff High School for Boys Academy 100% of students achieved A*/A grades in a cohort of 53 students
- The non-selective Eastwood Academy is notable for entering almost the entire cohort of students of 163 with 73.5% of students achieving A*- C grades, which is slightly above the figure for the national average of 71%
- Belfair's Academy achieved a pass rate of 85% at A*- C grades and 100% on A*-G on an entry of 14 students out of a cohort of 220
- Passes at A*- G of between 98.3% 100% were achieved by all schools which is an average across all schools of 99.4% which, again, is slightly above the national average of 97.8% and is to be celebrated

Governing Bodies will generally want to satisfy themselves that:

- the statutory requirements for schools to provide Religious Education for <u>all</u> students are being met at Key Stage 4
- the overall proportion of students being entered for any accreditation in RS at GCSE is appropriate given the number of students on role in the Borough (NOR) is declared as 2118 and number of entries (NOE) is declared as 1036
- that, while good teaching is being received by a small percentage of a cohort should more students be encouraged to choose RS as an option
 - o Some learners will not be entered for accreditation for a variety of understandable reasons, however, SACRE should satisfy itself that learners' entitlement to receive Religious Education is being met at Key Stage 4.
- the achievement of pupils in GCSE RS at A*- C and A*/A is sufficiently good

Achievement at Advanced Level in Religious Studies

Nine schools entered students for A Level RS, a total of 141 students. The number of students in the cohorts varied from 1 to 29. This is a very positive picture for A Level across the borough.

- Overall, students in Southend schools achieved well above the national figure at A*/A grades with 31.9% achieving this compared with the national figure of 24.4%.
- Similarly, 63.1% students achieved A* B grades, compared with a national score of 54.5%.
- In eight out of nine schools 100% of students achieved A*- E grades, including the small cohorts of the non-selective schools: Cecil Jones, Belfairs Academy and Shoeburyness High School
- St Bernard's achieved a pass rate of 93.1% but included within that figure 37.9% achieved a pass at 'A' grade which is significantly above the national figure of 18.9%
- At Southend High School for Boys, in a cohort of 17 students, 76.5% achieved A*- A, significantly above the national figure of 24.4%.
- Westcliff High school for Girls 16% achieved A*, which is three times the national figure
- A*- B grades exceeded national figures in five of the nine schools

Governors should consider the following points:

- The viability of A level cohorts which are very small in some schools
- Where number of students entered for GCSE A level is small, e.g. Belfairs, Cecil Jones, Futures, what provision is made for meeting the statutory requirements to teach RE to <u>all</u> pupils?
 - This question applies in <u>all</u> the schools where the GCSE cohort is less than the full cohort of students in that particular year.
- SACRE has commissioned a survey to engage with schools, including the growing number with academy status, to access the information it needs to continue to support schools in the Borough to sustain and improve upon the successes achieved this year.

Agreed Syllabus for Religious Education

The Borough's Agrees Syllabus has only been in place for one full and one part academic year, having been launched in September 2013, followed by a Teacher and Pupil Conference which was well-attended, evaluations show that teachers and schools were pleased with the new syllabus. There are no plans for a review until schools have had the opportunity to engage with it, teach the elements therein and then share their views through consultation, which will be sought during the academic year 2015 - 2016.

There are no figures provided from schools in respect of withdrawal from Religious Education and this is a question to be raised of schools in the next academic year 2015 – 2016. No complaints have been received by SACRE concerning Religious Education.

1.2. Teacher training and support

An experienced RE teacher/head of department supports the secondary RE network, which meets termly, on a voluntary basis. The Primary Network was restarted but following the completion of the 'Excellent RE' training programme provided by Culham St Gabriel's and led by RE Today Advisers. The core of teachers who attended expressed a wish to reinstate the Primary Network which will be led by Frances Neil as from September 2015, who will also attend the Secondary Network to make links between primary and secondary schools and teachers.

Links with other Agencies

We have been delighted to have been supported by RE Today, whose adviser, Kate Christopher has attended SACRE to support them in their work.

1.4. GOVERNOR TRAINING

No governor training on RE or collective worship was held during the year.

1.5. TEACHER TRAINING

Specialist advice and support is available for schools through the Primary and Secondary termly network meetings and through training courses run in conjunction with NATRE.

1.6. COMPLAINTS CONCERNING RE

No formal complaints were made about religious education under the local statutory complaints procedure during 2014 - 15.

2 COLLECTIVE WORSHIP

2.1. MONITORING

THE **SACRE** HAS HIGHLIGHTED MONITORING OF THE PROVISION AND QUALITY OF COLLECTIVE WORSHIP AND THE PROVISION OF TRAINING FOR SCHOOLS AS A PRIORITY FOR 2015 - 16.

2.2. TRAINING

There has been no training for schools on collective worship during the year.

2.3. DETERMINATIONS

There were no applications for determinations to alter the character of collective worship for all or some pupils in a particular school during 2014-15.

2.4. COMPLAINTS CONCERNING COLLECTIVE WORSHIP

No formal complaints were made about collective worship under the local statutory complaints procedure during 2014-15.

3. LINKS WITH OTHER AGENCIES

3.1. NATIONAL

Southend SACRE is a member of the National Association of SACREs (NASACRE). Members attend conferences and other events and report to full SACRE meetings.

3.2. LOCAL

During the year SACRE meetings have been held at local schools and places of worship, including St Lawrence and All Saints Church. Meetings in schools have included contributions from the Headteachers and teaching staff followed by opportunities for members of SACRE to discuss their provision for RE and collective worship.

4. OTHER ISSUES

4.1. BUDGET

The Local Authority has delegated a reasonable sum of money to SACRE to enable the group to function independently and effectively. The funds are allocated carefully. Expenditure includes national association affiliation fees and incidental expenses, for example, travel and venue costs.

CONSTITUTION, TERMS OF REFERENCE AND & MEMBERSHIP OF SOUTHEND SACRE FOR 2014-15

APPENDIX A

Constitution, Terms of Reference and Membership of the Southend SACRE

Constitution of the Southend SACRE

Role and Functions

i. To advise the LEA upon matters connected with religious worship in its schools.

- ii. To advise the Authority upon the religious education to be given in its schools in accordance with the Southend Agreed Syllabus. In particular it can offer advice on methods of teaching, the choice of materials and the provision of training for teachers.
- iii. To determine and review the cases in which the requirement for Christian collective worship is not to apply.
- iv. To review the Local Authority's Agreed Syllabus.
- v. To write an annual report on its work which will:
 - specify any matters in respect of which the SACRE has given advice to the Authority;
 - broadly describe the nature of the advice given;
 - Where any such matter was not referred to the SACRE by the Authority, give the SACRE's reasons for offering advice on that matter.

Copies of the report must be sent to schools, the Schools' Curriculum Assessment Authority and the local teacher training institutions.

- vi. At the discretion of the Authority the SACRE may:
 - monitor RE provision to inform their advice and reporting;
 - be involved in the Complaints Procedure;
 - Arbitrate, as necessary, whether acts of worship provided for withdrawal groups meet the requirement of Section 351 of the Education Act 1996.

For i. and ii. above the Authority may refer matters to the SACRE or the SACRE may decide its own areas of work.

Officers

- i The Chief Executive and Town Clerk of Southend-on-Sea Borough Council shall be the Clerk to the SACRE.
- ii. The Corporate Director for People shall attend and participate in discussions of the SACRE as professional adviser.

Membership

In accordance with the provisions of the Education Act 1996 (Section 390);

- i. the SACRE is to comprise four groups representing respectively:
- a. such Christian and other religious denominations as, in the opinion of the Authority, will appropriately reflect the principle religious traditions in the area;
- b. the Church of England;
- c. such associations representing teachers as, in the opinion of the Authority, ought to be represented, having regard to the circumstances of the area;
- d. the Local Education Authority:

- ii. The Authority has to take all reasonable steps to assure itself that the persons appointed under i. are representative of the denominations or association in question;
- iii. the Authority may remove a member of the SACRE if in the opinion of the Authority that member ceases to be representative of the denomination or association which he/she was appointed to represent;
- iv. Any member may resign at any time.

The composition of Southend-on-Sea Borough Council SACRE is set out in Annex A.

Term of Office of Members

The term of office for members of the SACRE shall be for four years from the date of appointment by the relevant body.

Disqualification from Membership

Where a nominated representative fails to attend three consecutive meetings of the SACRE she/he shall cease to be a member of the SACRE and the nominating body shall be invited to nominate another representative. See also 3 iii. above.

Vacancies

A member appointed to fill a vacancy shall hold office only for the unexpired term of office of the member in whose place he/she is appointed.

Any vacancy occurring within three months of the expiration of the term of office of a member need not be filled.

Deputies

- i. Each nominating body* having not more than 5 representatives on the SACRE may nominate one named deputy.
- ii. Nominating bodies having 6 or more representatives may appoint 2 named deputies.
- iii. Only named deputies may attend or vote in place of a member.

Chairman & Vice-Chairman

- i. The Chairman shall be elected annually for a period of one academic year. The election of Chairman shall be the first item of business on the agenda for the ordinary meeting held every Autumn Term. The election will be by a simple majority of those members of the SACRE present at the quorate meeting.
- ii. The Vice-Chairman shall be elected annually for a period of one academic year. The election of Vice-Chairman shall be the second item of business on the agenda for the ordinary meeting held every Autumn Term. The election will be by a simple majority of those members of the SACRE present at the quorate meeting.

Voting

i. With the exception of the appointment of Chairman and Vice Chairman, on any question to be decided by the SACRE only the representative groups on the SACRE shall be entitled to

vote, and each group shall have a single vote. Decisions made within each group require a majority vote as do decisions made by the SACRE.

ii. Each representative group has a single vote on the question of whether to require a review of the Authority's agreed syllabus except the Authority group (See 1 iv).

Co-options

The SACRE may co-opt members on the nomination of any of the groups. Such co-opted members may participate fully in the discussions of the SACRE but may not vote.

Quorum

The meeting of the SACRE shall be quorate only if each of the four groups is individually quorate as follows. A quorum shall consist of 5 members of each group or one third of the members of each group, rounded to the nearest whole number, whichever is the lower, i.e. a quorum shall consist of:

Church of England Group 2

Other Faiths Group 3

Teachers' Associations Group 2

Local Education Authority Group 2

* Note: Individual teacher associations within Group C and individual political parties within Group D are to be regarded as "nominating bodies" for this purpose.

Frequency of Meetings

The SACRE shall normally meet at least once in every school term. The four Groups may meet beforehand if they wish.

Notice of Meetings

At least 7 clear days before each meeting of the SACRE the clerk shall send notices to every member setting out the business to be transacted. Items for the agenda may be submitted by any of the four groups, and such items should be sent to the Clerk and at the same time to the Corporate Director for People, not less than 14 days before a meeting.

Meetings of Four Groups

Each of the committees of the SACRE may hold its own meetings, and shall make its own arrangements to appoint a Chairman and Vice-Chairman.

Sub-Committees

The SACRE may constitute sub-committees to deal with particular matters as and when it sees fit. Seven clear days' notice of meetings of any such sub-committees should be given to the members thereof.

Minutes

Minutes of each meeting shall be sent by the clerk to each member as soon as practical after a meeting. The minutes shall be confirmed and signed at the next meeting.

Submission of Minutes to the Local Authority's Cabinet

Decisions which cannot be made by the SACRE shall be referred to the Local Authority's Executive decision making body (The Cabinet) and shall be eligible for call-in to the People Scrutiny Committee. The Clerk shall submit the minutes of SACRE meetings

Availability of Papers to the Public

- i. All papers of the SACRE shall be available to the public, except in relation to any information defined as confidential in regulation 9 of the Religious Education (Meetings of Local Conferences and Councils) Regulations 1994.
- ii. All meetings of the SACRE and of any sub-committee of the SACRE including the four groups which constitute the SACRE, shall be open to the public, except that the public may be excluded from any meeting during an item of business whenever it is likely that, if members of the public were present, confidential information as defined in regulation 9 of the Religious Education (Meetings of Local Conferences and Councils) Regulations 1994 would be disclosed.

The SACRE RETool: Reporting and Evaluating Toolkit

Introduction

The essential role of the SACRE is to support its Local Authority (LA) and the local authority's schools in meeting the entitlement of pupils across the local authority to engage in high quality Religious Education and Collective Worship. In an educational context where standards and accountability are at the top of the agenda, a SACRE's work has become increasingly challenging and diverse, but also more rewarding and stimulating. Good SACREs will therefore tackle their responsibilities and opportunities with enthusiasm, whilst recognising the need for realistic and ongoing appraisal and self-review.

In many ways SACREs reflect the work of governing bodies in schools, in so far as they act as critical friends to the local authority on matters of religious education and collective worship. Like school governors, members are unpaid volunteers who give up their time to support religious education (RE) and collective worship locally.

This Reporting and Self-Evaluating Toolkit is an amended version of the original SACRE SEF (2004). It takes account of changes in inspection arrangements and in the role of local authorities, and of the development of maintained schools independent of their local authority. It is designed to help individual SACREs evaluate their role and, in particular, to consider their impact on pupils' educational experience and learning. It also helps SACREs review their organisational patterns and structures, and their partnership with the local authority and other key stakeholders.

The Toolkit highlights five key dimensions of a SACRE's work and provides exemplification of good practice. A SACRE that uses this self-evaluation guidance should gain a clear picture of its strengths, identify areas for further development, and establish its key priorities for action.

The DCSF publication "Religious education in English schools: Non-statutory guidance" (2010) ("the Guidance") remains the most recent official statement in this field: https://www.gov.uk/government/publications/religious-education-guidance-in-english-schools-non-statutory-guidance-2010. The Guidance sets out the responsibilities of SACREs and Local Authorities as well as those of other stakeholders in RE. Key summaries from the Guidance are included in the Annex to this document.

Rationale

.The RETool focuses on the following five aspects of the work of SACREs:

- 1. promoting improvement in the standards, the quality of teaching, and provision in RE
- 2. evaluating the effectiveness of the locally agreed syllabus
- 3. promoting improvement in the provision and quality of collective worship
- 4. managing the SACRE and building the partnership between the SACRE, the LA and other key stakeholders
- 5. contributing to cohesion across the community and the promotion of social and racial harmony.

Each aspect forms a section within the RETool matrix and each section is divided into focus questions to help SACREs explore their provision. Descriptors for 'Developing'. 'Established' and 'Advanced' practice will enable SACREs to evaluate their standing within each focus question.

In the final column SACREs may wish to identify any issues and action points within that focus as appropriate. Key priorities can then be identified at the end of each section to inform the development of an action plan.

The intention is that, over time, exemplars of good practice from different SACREs will be made available on an open website, together with annual reports, as a way of adding further support to SACREs and local authorities. Clearly the capacity of any SACRE to make the most of this will be dependent on the extent of the support it receives from, and the quality of its relationship with, its Local Authority.

SACREs are invited to use the format of this RETool to compile their annual report to their local authority. A copy of the annual report should also be lodged electronically with the central database memsec@nasacre.org.uk When compiling their report, SACREs could either use the entire RETool document, or copy sections of text from it into another document; the annual report could focus on specific areas in any given year.

Section 1. Standards and quality of provision of Religious Education

How effectively does the SACRE, in partnership with the LA, evaluate standards and the quality of provision for RE in schools?

How effective are the strategies to improve standards and the quality of provision?

In principle, every pupil is entitled to RE of the highest quality. At its best RE will be one of the most popular, relevant, stimulating and truly educative elements in the curriculum. This potential gives SACREs both a benchmark for their aspirations, and a spur for their actions.

A core duty of a SACRE is to gain an overview of the quality of the RE provision in local authority maintained schools and to develop effective strategies to promote the highest standards. SACREs may also request information from Academies, academy chains and Free Schools where they educate pupils from the local authority which appointed SACRE. In the light of the current inspection culture of partnership and self-evaluation, SACREs will need to approach the achieving of this overview with some sensitivity and astuteness.

Information to assist the SACRE in carrying out its role is likely to come from a range of sources. This may include:

- public examination results
- · reports from School Improvement Partners
- analysing questionnaires
- sharing of information from subject self-evaluation forms as appropriate, and in agreement with schools
- feedback from professional development activities
- presentations to SACRE from local teachers

The Guidance offers analysis and advice to support SACREs in reviewing their own effectiveness, their patterns of partnership, and their strategies in relation to enhancing the quality of RE provision in local authority maintained schools. In addition, in the light of the development of academies and other non-LA maintained schools, SACREs also need to take note of and respond appropriately to this new diversified scenario. (In the ensuing pages, the phrase "academies etc" is used as shorthand to refer to all non-LA maintained schools within a particular LA area.)

Successes/ What are we good at?

SACRE is mostly identified as 'established' from the SET details above. The RE Survey has been the main vehicle for gathering data, along with that shared within the Teachers' Network meetings.

Barriers to success

SACRE's insecurity about its role due mainly to gaps in SACRE's knowledge relating to its scope and statutory responsibilities. Training for this has been organised in September 2015 by RE Today.

Areas for development/ Action points:

- For the SACRE
- Training in its statutory role and responsibilities
- Gathering data from special schools, academies and maintained schools relating to the appointment/retention of RE Leads / HOD / teachers / post holders

Section 2: The effectiveness of the locally agreed syllabus

How effectively does the SACRE, in partnership with the LA, monitor the impact and evaluate the effectiveness of the agreed syllabus in raising standards? How effectively does the Agreed Syllabus Conference in partnership with SACRE make decisions about the use of national guidance and exemplar material in a review of the agreed syllabus?

The locally agreed syllabus is the bedrock on which schools will build robust sequences of effective learning experiences in RE. A good modern AS will support both the delivery of high quality RE in schools and RE's contribution to the schools' wider curriculum aims and impact measures.

The major factors to be considered in creating or revising an AS include statutory requirements, non-statutory guidance and exemplar material, developments in the school curriculum generally, and local circumstances. Key advice on producing an AS is given in the Guidance. SACREs and ASCs are recommended to take note of this advice in their work on the AS.

Local authorities are required to review their locally agreed syllabus at least every five years. This cycle of reviewing, relaunching and re-implementing the AS gives SACREs and ASCs opportunities for ongoing development and improvement of their effectiveness in providing schools with a locally agreed syllabus that is truly "fit for purpose".

While the ASC holds the legal responsibility for revising the agreed syllabus, in practice much of the preparatory and supplementary work will be carried by the SACRE within its routine business. Moreover, in most LAs the membership of SACRE and ASC overlap substantially or are identical. This can contribute to greater inclusiveness and coherence, but good practice will ensure that it is always clear at any time which body is in place at a meeting, and that it is the ASC which is in session when formal decisions about the AS are to be considered.

Academies etc are in principle free to choose their own RE syllabus. In practice, however, many may well continue to use their local AS. There are some sound reasons for SACRE and the LA to encourage this where possible, and to enable academies etc to have some involvement in the process of revising the AS or of devising a new AS. Relationships between SACREs and academies will necessarily be entirely voluntary and not covered by existing legislation or guidance. SACREs should therefore approach such relationships in a spirit of mutual respect and collegiality. These issues have not been incorporated into the matrix below, but see Section 4.

Section 3. Collective worship

How effectively does the SACRE fulfil its responsibilities for the provision and practice of collective worship?

Maintained schools are required to provide a daily act of collective worship for every pupil. In community schools not having a religious foundation, the acts of collective worship should be "wholly or mainly of a broadly Christian character", without being distinctive of any particular denomination. Part of a SACRE's role is to support the effective provision of collective worship in community schools and to advise the LA on issues related to provision and quality. It must also consider applications from head teachers in community schools that the requirement for collective worship to be wholly or mainly of a broadly Christian character be disapplied for some or all of the pupils in that school. SACRE 'determines' the appropriateness of that application and grants a 'determination' to those schools where the application is judged to be in the best interests of the pupils. All pupils in schools with determinations continue to have an entitlement to daily collective worship.

Collective worship can be a rich and rewarding element of the curriculum as a whole. SACREs have the opportunity to enhance the quality of collective worship by appropriate guidance and support.

Section 4: Management of the SACRE and partnership with the LA and other key stakeholders

How far does the SACRE's partnership with the LA enable it to carry out its responsibilities effectively?

The relationship between a Local Authority and its SACRE is essentially one of partnership and collaboration, with mutual obligations and responsibilities. So that a SACRE can advise and act effectively for the LA in the field of Religious Education and collective worship, the LA must ensure not only that there is a local SACRE, but also that it is able to fulfil its functions. The extent to which a SACRE is supported, by funding and personnel, will determine how well individuals and committees can work together. Where a SACRE is valued by the Local Authority, it is more likely that the members of the SACRE will be able to contribute both to the SACRE's work and to the LA's wider strategic objectives.

By bring together many local stakeholders (faith/belief communities, teachers, local politicians and cooptees such as universities and parents) into a statutory body, SACREs can act positively for LAs as a sounding board on their core business of RE and collective worship, and also on wider strategic educational objectives such as raising standards, narrowing the gap and promoting community cohesion, as well as community matters related to interfaith collaboration and wellbeing. These core and value added functions work best when the SACRE is appropriately supported, resourced and managed, and when channels of communication with the LA are good.

The potential for SACREs to contribute more widely is dependent on SACRE members feeling that the meetings are outward looking, focused on pupil needs, purposeful and enjoyable. This can be achieved, for example, by meeting in different locations (schools, places of worship, cultural centres and Council meetings rooms) and by ensuring that all members feel they are equal partners whose views and experiences are sought, listened to and valued.

Alongside this, SACRE has the power to develop structural relationships with academies etc by exploring ways in which an academy "presence" can be incorporated into SACRE itself, e.g. by co-options (non-voting), through additional places in Group C (teacher organisations), or by creating a non-voting notional "Group E" (as had been envisaged in the Grant Maintained era). Similar considerations apply to the ASC. Although the legal framework would currently not allow voting rights to any distinct academy representation, SACREs and ASCs would surely not wish to proceed with decisions which were clearly not acceptable to the academy sector represented in their wider membership.

Section 5: Contribution of SACRE to promoting cohesion across the community

How effectively does SACRE, in partnership with the Local Authority and the faith communities, contribute to the promoting of cohesion across the community?

"By community cohesion, we mean working towards a society in which there is a common vision and sense of belonging by all communities; a society in which the diversity of people's backgrounds and circumstances is appreciated and valued; a society in which similar life opportunities are available to all; and a society in which strong and positive relationships exist and continue to be developed in the workplace, in schools and in the wider community".

Schools play a major role in helping to shape the future of our society, and the duty laid on each school to promote community cohesion is a significant part of that role. One of the most obvious and effective contributors to the community cohesion agenda is Religious Education. SACREs should take every opportunity to promote the contribution of RE to the community cohesion programmes in local schools. Where properly supported by the LA, SACREs themselves can act as powerful vehicles for promoting community cohesion in schools, in education more widely, and in the local community. SACREs should exemplify good practice in their internal relations and in the ways in which they go about their business. Advice on the contribution of SACREs and RE to community cohesion is given in the Guidance.

ANNEX

The responsibilities of a Local Authority

The detailed rights and responsibilities of local authorities can be seen in full in *RE in English Schools: Non-statutory guidance 2010*. This can be found at http://www.teachernet.gov.uk/teachingandlearning/subjects/re/guidance/

In brief, local authorities are legally required to:

- establish a SACRE and appoint representatives to each of the four committees
- establish an occasional body called an agreed syllabus conference (ASC)
- institute a review of its locally agreed syllabus every five years
- appoint members of the committees represented on the ASC
- ensure that membership of group/committee A on the SACRE and ASC is broadly representative of the local area
- take all reasonable steps to ensure that SACRE and ASC membership is representative

The responsibilities of a SACRE

The detailed rights and responsibilities of SACREs can be seen in full in *RE in English Schools: Non-statutory guidance 2010*. This can be found at http://www.teachernet.gov.uk/teachingandlearning/subjects/re/guidance/

In brief, SACREs are legally required to:

- advise the local authority on RE and collective worship
- publish an annual report on their work
- send the annual report to QCDA (or its successor body)
- meet in public, unless confidential information is to be disclosed
- make their minutes available to the local authority and make provision for public access to their agenda and reports

The Guidance also indicates that SACREs should, as a matter of good practice:

- Monitor the provision for both RE and Collective Worship
- Provide advice and support on RE and Collective Worship to schools
- In partnership with the local authority, keep the locally agreed syllabus and provision in schools under review
- Offer advice to the local authority

In addition, SACREs may:

- Require their local authority to review the locally agreed syllabus
- Decide to advise their local authority
- Co-opt members who are not members of any of the four groups.

The Guidance also makes it clear that SACREs can and should make a strong contribution to the promotion of community cohesion in schools and in the local community through their promotion of good quality RE and through their operation as a SACRE.
