## 683 Minutes of the Meeting held on Thursday 3rd September 2015

## 684 Application to be recognised as an association for taxi drivers

The Committee was informed that this item had been withdrawn from the Agenda on the basis that the formal application and supporting documentation had not been received. Resolved:-

## 685 Consultation of the proposed Gambling Policy for 2017

The Committee received an oral report and presentation from the Council's Regulatory Services Manager on the proposed changes to the Gambling Licensing Policy Statement 2017-19. A copy of the policy statement was presented to the Committee to enable its views to be forwarded to the Cabinet as part of the consultation process. The Committee also received, for information purposes, a summary of the consultation responses that had been received to date.

The Committee considered and discussed the policy statement in some detail, and noted the requirement for applicants to carry out (and review as necessary) their local risk assessments. Furthermore, in order to assist applicants, where there is an issue in a local area which impacts on how the applicant should complete their risk assessment, the Committee noted that it was proposed that the Licensing Authority would be publishing a local area profile (LAP). The LAP would be published as a separate document to the policy statement and would not form part of it. An initial draft copy of the LAP was circulated at the meeting. The Committee also noted that approval would be sought to delegate any necessary amendments to the LAP to the Deputy Chief Executive (Place) to ensure the information included within it was up to date and accurate.

Resolved:-

1. That, subject to the amendment of the term "Criminal Records Bureau" to "DBS" or "Disclosure" check in paragraphs 25.2 and 27.1, the proposed changes to the Gambling Licensing Policy Statement 2017-19 be supported.

2. That the Cabinet be recommended to approve the publication of the LAP as a separate document to the policy statement and that the LAP should include, amongst other things, areas of depravation to assist in the completion of risk assessments.

## Application to be recognised as a taxi drivers association Chairman of the Licensing Committee C – Councillor David McGlone *A Part 1 Public Agenda Item*

#### 1. Purpose of Report

1.1 Members are invited to consider an application from the AC Drivers Association (ACDA) to be recognised where appropriate by this Authority for the purposes of consultation, negotiation and representation on behalf of licensed Hackney Carriage and Private Hire drivers, together with other representatives of the trade who in the past have been recognised to the same extent.

#### 2. Recommendation

- 2.1 Members recognise where appropriate the AC Drivers Association for the purpose of seeking their views by consultation and representation in relation to Hackney Carriage and Private Hire licensing matters.
- 2.2 This recognition shall be limited to the same extent as that currently enjoyed by other similar organisations representing the trade, namely (at the current time) the Southend Licensed Taxi Drivers Association, the Southend Private Hire Association, the GMB Union and the Thames Axis Group of the Unite Union (formerly Transport and General Workers Union).

#### 3. Background

- 3.1 The Licensing Committee has, for several years, recognised and has consulted with Southend Licensed Taxi Drivers' Association, the Southend Private Hire Association and the GMB and Unite unions in matters concerning Hackney Carriage and Private Hire licensing.
- 3.2 The ACDA is a newly established organisation in the Borough representing Hackney Carriage drivers on the AC taxi circuit licensed by this Authority. A letter from the association requesting recognition together with AGM minutes and a copy of the constitution of the ACDA are attached at **Appendix 1**.
- 3.3 The number of members licensed by this Authority driving on AC is currently believed to be in excess of 200.



- 3.4 Currently Officers will accept requests and representations for private hearings with Trade Representatives to discuss concerns they may have; will discuss, consult and consider suggestions with the trade as appropriate and will notify and copy the trade reports and agendas of Licensing Committee meetings where Taxi/Hire Car matters are to be discussed.
- 3.5 Members of the Licensing Committee currently allow these trade bodies to represent, consult and make suggestions (by letter or in person) at Committee meetings before making final decisions.

## CONSTITUTION

#### Governance:-

All accounts and fees will go through our elected committee with one member whose duty it will be to oversee all financial arrangements and membership. AC Taxi Ltd has put at AC Drivers Association disposal the use of their accounts department to keep the correct financial records as required by Southend Borough Council. All records will be made available to Southend Borough Council on request.

AC Drivers Association to be funded by its membership.

## **OBJECTIVES:-**

To work with Southend Borough Council and its officers to improve our members working condition. To enhance safety at all times for all.

To improve the day to day Taxi service in Southend – on – Sea Licensed area to the benefit of the travelling public.

To work with SBC officers or any other agency to reduce the carbon footprint in Southend.

To enhance the use of zero emission vehicles as Taxis.

To Bring to the forefront, modern day technology and explain the benefits of duel fuel or all electric Taxis, that will be a requirement in the world of tomorrow.

To enhance our duty of care and safeguarding.

#### MEMBERSHIP & RULES

Membership is open to any Licensed Southend Hackney Carriage driver that drives on AC Taxi circuit.

Only an AC driver can receive the full benefits of membership, however we will help and support when asked any Southend licensed Driver.

#### RULES

AC Drivers Association insists that every member must at all times abide by Southend Council Licensing terms and condition, to include all by- laws and common law. This forms part of our Code of Practice, any breach of our Code of Practice will be investigated and reported.

#### MEETING RULES

Meetings will take place once a month except in the month of December.

Meetings to be attended by all committee members when possible, apologies will be accepted.

A minimum of 2 executive members and a minimum of 3 non exec - committee members.

Chairperson of the meeting has the deciding vote if required.

Members can sit in on committee meetings as an observer only and by invitation. Max of 2 per meeting.

Any item up for discussion at a monthly meeting must be put to the Secretary at least 24hrs prior to the meeting taking place.

All items to be discussed must be entered on the agenda

All meetings to have recorded minutes.

Only the chairperson as he deems fit can co-opt members to serve on the committee

AGM

An AGM will take place once every calendar year.

A full report and minutes must be published and be made available.

All members must be given 21 days' notice of an AGM

All current committee members Exec and non – exec must stand down from their duties.

A non-committee person to take charge of the meeting, as nominated by the outgoing Chair, until a new Chairperson has been nominated.

Members will be asked to vote for Executive Committee members only.

The Chairperson position to be voted for first.

On the election of the new Chairperson, the new Chairperson takes control of the meeting

Voting continues until all Executive Committee positions are filled.

Nomination for non- exec committee members to be taken from the floor at the chairpersons desecration

EGM

An EGM can be called at any time during the year. This type of meeting can only be called as a matter of urgency.

EGM can only be called by Chairperson or Deputy Chairperson in the absence of the current Chairperson.

RESOLUTION

Our resolution is that by having regular meetings and listening to the membership, we can as an association and the elected voice of our membership, bring constructive objectives and reasoning to the officers of Southend Borough Council in the best interest of all parties concerned.

Whether it be on enforcement, tariffing, training or safeguarding.

We as an elected association on behalf of our members have a duty to bring to the attention of our licensing authority any such worries or concerns that affects their safeguarding.

To further the efficiency of service to the general public.

To facilitate the exchange of ideas and methods.

To foster the continuity of the Association.

To advise in the enactment of just, equitable and constructive legislation.

To assist its members in all and every way possible.

To encourage the development of younger members.

To gather, organise and to keep on file useful information.

Through proper operation of this Association and integration of the creative forces and its command, to act or co-act with others and especially with Local Authorities in the improvement of the economic, social and civic values of the licensed hackney carriage trade. To protect the vested interests of its members and secure the living standard and welfare of all who are engaged in the industry.
