## **Review of Polling Districts and Polling Places**

A Part 1 Public Agenda Item

### 1. Purpose of Report

1.1 This report proposes amendments to polling districts and polling places in the parliamentary constituencies of Southend West and Rochford and Southend East that fall within the Borough.

### 2. Recommendations

- 2.1 That the comments received in response to the public consultation exercise on the polling districts and polling places, as set out in <u>Appendices 2 and 5</u> to this report, be noted.
- 2.2 That the proposed amendments to the polling districts and polling places, as set in the Report of the Returning Officer (<u>Appendix 3</u>), be approved.

## 3. Background

- 3.1 The Representation of the People Act 1983 ('1983 Act') places a duty on the Council to divide the Borough into polling districts and designate polling places for the districts. The Council has a duty to keep these polling arrangements under review.
- 3.2 The Electoral Administration Act 2006 introduced a number of changes to the 1983 Act in respect of the way reviews must be undertaken. Under the 2006 Act, the Council was required to undertake a review of polling districts and polling places within their area on a four yearly cycle. The last general review in Southend was completed on 18<sup>th</sup> November 2014.
- 3.3 The Electoral Registration and Administration Act 2013 introduced a change to the timing of the statutory reviews. The next compulsory review has to be completed by 31<sup>st</sup> January 2020.

- 3.4 An explanation of the terms used in the review is set out below:
  - i) A polling district is a geographical area created by the sub-division of a constituency into smaller parts. For voting purposes, each parliamentary constituency and every local government ward is divided into one or more polling districts. The polling districts for the Borough elections mirror those for the parliamentary elections.

The review can only address issues within the current ward structure of the Borough. It cannot make changes to the ward (or Borough) boundaries. There are some areas where moving a ward boundary might resolve an anomaly concerning the allocation of voters to polling stations, but this cannot be achieved as part of the review.

- ii) A **polling place** is an area within a polling district in which a polling station is located. There is no legal definition of a polling place which could be as large as a polling district or as small as a particular building. The Electoral Commission is aware that some authorities designate the entire polling district as the polling place. However, Section 18 of the 1983 Act states that 'the polling place must be small enough to indicate to electors in different parts of a district how they will be able to reach the polling station'. The Commission therefore recommends that the polling place should always be defined. It was agreed at the meeting of the General Purposes Committee on 16<sup>th</sup> November 2011 that a polling place be defined as the building (including the surrounding grounds) within which the voting may take place.
- iii) A **polling station** is the room or area within the polling place where voting takes place. Unlike polling districts and polling places which are fixed by the local authority, polling stations are determined by the Returning Officer for the election.
- 3.5 The aims of the review were to seek to ensure that:
  - all electors have such reasonable facilities for voting as are practicable in the circumstances.
  - as far as is practicable, every polling place is accessible to electors who are disabled.
  - the polling place(s) for a polling district is within the area of the polling district unless special circumstances make it desirable for the polling place to be outside the polling district area (i.e. because suitable alternative buildings are not available in the area).
- 3.6 In an ideal world, the Returning Officer would have the choice of a range of fully accessible buildings, conveniently located for the electors. The Electoral Commission recognises that, in practice, this is not the case and there may actually be little choice available. Where it is necessary to use a polling place where the access is not ideal, the Commission expects the Council to make reasonable adjustments to provide access to all electors.

- 3.7 The Commission also recognises that in reality the choice of polling place will often be the balance between the quality (access, facilities etc) of a building and the distance between the residents and that building compared to other options for polling places.
- 3.8 The law makes provision for the Returning Officer to use schools (including academies) free of charge for the purposes of an election, subject to covering certain costs including heating, lighting and caretaking charges. Returning Officers do use schools because they are well known venues within the community and can be provided at less cost to the public purse. In the Borough, the use of the smaller schools are generally avoided where possible as this could result in the closure of a school or part of a school on polling day. However, it must be emphasised that there are areas in the Borough where there are no suitable alternatives available.
- 3.9 The use of portable buildings as polling stations are also avoided where possible, primarily because of the additional costs to the public purse that arise from the hire, delivery, siting, setting up and equipping of a portable unit. The number of suppliers in this region have reduced, putting pressures on the availability of suitable units. This form of accommodation is less than satisfactory in comparison with most of the buildings used as polling stations and problems are often experienced with the use of portable buildings at election time, such as:
  - limited in size and location;
  - limited facilities for polling staff;
  - suitability in cold/wet/inclement weather;
  - poor public perception;
  - power supply limitations;
  - prone to vandalism
- 3.10 The Electoral Commission recommends that there should be a minimum of one polling station for every 2,500 electors voting in person. Generally, where elector numbers are of concern and exceed the recommended threshold, the best solution is the addition of a further polling station within the same polling place. In the case of the last election, 16 out of the 65 buildings used were double polling stations.

## 4. The Review Process

- 4.1 In undertaking the review, local authorities are required to:
  - Publish a notice of holding a review.
  - Seek representations from such persons that it thinks have particular expertise in relation to access to premises or facilities for persons with any type of disability.
  - Publish the report of the Returning Officer setting out their proposals.
  - On completion of the review, complete and adopt a revised scheme, which must be published.

- 4.2 The formal consultation on existing polling districts and polling places (Appendix <u>1</u>) commenced on 9<sup>th</sup> August 2019 upon the publication of a notice seeking comments by 16<sup>th</sup> September. Details of the review were publicised through the Council's website, libraries and the press and comments were sought from the local Members of Parliament, Southend Councillors and a number of other individuals/organisations. The representations received in response to the initial consultation exercise are set out in <u>Appendix 2</u> to the report.
- 4.3 Following the conclusion of the exercise, the report of the Returning Officer setting out her proposals was also published for consultation (<u>Appendix 3</u>) and comments were invited by 1<sup>st</sup> November 2019.
- 4.4 A number of responses were received in respect of the consultation on the Returning Officer's report on her proposals. These are set out at <u>Appendix 5.</u>
- 4.4 Councillors are asked to be mindful that over the years, much work has been undertaken to ensure that the polling arrangements are convenient to electors across the Borough. The boundary changes to Borough and Parish wards and changes implemented following the previous reviews of polling districts have improved the arrangements. The proposed changes to the polling district boundaries are set out in the Report of the Returning Officer (Appendix 3).
- 4.5 An access survey was undertaken in respect of all of the buildings used as polling stations as part of a previous review. The findings resulted in some accessibility improvements to a number of the buildings. There have also been a number of improvements made to polling places/stations following the previous reviews. After each election, observations received from the Returning Officer, polling station inspectors and presiding officers are considered and used to implement changes. This feedback has helped to highlight premises where additional measures are required from the simple provision of more direction signage to the installation of ramps, or even a change in a polling place.
- 4.6 The proposed changes to the polling districts and polling places are set out in the Report of the Returning Officer (<u>Appendix 3</u>). Maps showing the proposed changes are included in the paperwork at <u>Appendix 4</u>.

## 5. Other Options

A number of alternative premises have been considered for use as polling places and recommendations made accordingly where it is felt that an alternative would provide better voting arrangements or the premises concerned would improve accessibility.

A public notice of the review was displayed at the Council offices and full details of the review were placed on the Council's website. All Councillors were notified of the review process and a number of individuals/organisations were invited to submit their representations to the Council.

The Council's Returning Officer has produced her report setting out suggested changes to polling districts and polling places. The report was publicised and comments were sought from a range of interested parties.

6.7 Equalities and Diversity Implications

The Council reviews its polling places/stations on a regular basis with a view to ensuring that they are all fully accessible as far as is reasonably practicable. In some cases the polling stations are not accessible to the extent that would ideally be desired, but much work has been undertaken to identify the most suitable premises for use as polling stations and to minimise use of mobile polling stations. An equality analysis has been undertaken as part of the review.

The Council is required by law to undertake a review of polling districts and polling places within its area. Failure to do so would constitute a breach of the relevant statutory requirements and adversely affect the reputation of the Council.

**NOTE 1:** The Association has submitted a detailed request requesting amendments to the location of polling stations in Milton Ward. This includes the cessation of the St Johns Church and the return of the Foyer at the Cliffs Pavilion. It is accepted that the location of the polling station at St Johns Church is not ideal. The Cliffs Pavilion is however, no longer considered appropriate given the nature of some of the events and the location of a bar in the foyer. It is therefore proposed to review some of the polling district boundaries with Milton Ward, reducing the number of polling districts from 6 to 5, and the relocate the polling station from the St Mark's Church Hall to the Forum as illustrated in Proposals Map 1.

**NOTE 2:** Residents in MacDonald Avenue have requested that their polling station be relocated back to the Westborough School. The polling station for this polling district is The Guild Hall, Hill Road. The polling station at Westborough School, MacDonald Avenue is for the neighbouring polling district WP. It is evident that the current arrangements are unclear for voters particularly for those electors residing in very close proximity to the School. Looking to the future, the former Prospects College site is currently being redeveloped as residential and there are proposals for the redevelopment of the Roots Hall Stadium. It would therefore seem appropriate to split the polling district WN (as illustrated in Proposals Map 2. The electors in the western half could be directed to a double polling station at the Westborough School and those in the eastern half could retain the Guild Hall as the polling station.


**NOTE 3:** The Garrison is a walled enclave to the north with only one small pedestrian exit into Shoebury High Street and a cycle path into Rampart Terrace at East Beach. Access to St Peter's Church Hall, the current polling station for this polling district is therefore quite difficult for a number of voters from the Garrison site. The electorate in EA is 2709 (2326 net of postal voters) which is very high and is likely to increase with the potential of development of new homes within the Garrison site. It is therefore proposed that the Polling District be divided as shown on Proposals Map 3. One Polling Station be retained at St Peter's Church Hall and the new polling station be located within a room at Hinguar School.

NOTE 4: The Association has submitted a detailed request requesting amendments to the polling district boundaries and the number of polling districts in Southchurch Ward. Its is recommended to amend the polling district boundaries and poling stations as illustrated in Proposals Map 4.



## Existing arrangements for Polling Districts within Milton Ward




# Proposed arrangements for Polling Districts within Milton Ward




## PROPOSALS MAP 2 PRITTLEWELL WARD

## Existing arrangements for Polling District WN






# PROPOSALS MAP 3 SHOEBURYNESS WARD

## Existing arrangements for Polling District EA






# PROPOSALS MAP 4 SOUTHCHURCH WARD

## Existing arrangements for Polling Districts within Southchurch Ward






# PROPOSALS MAP 5 WESTBOROUGH WARD
