# Listening To Views

---

- Extended period for receipt of consultation responses (23 March)
- Provision of supplementary materials relating to Orsett proposals (video, supplementary documentation, specific survey)
- Recording of public event for sharing via social media (Rayleigh, 7<sup>th</sup> March)
- Revisit GP practices to replenish supplies of consultation materials
- Paid news advertisements to alert individuals to extended consultation date
- Clinical transport discussion paper produced
- FAQs updated and posted on-line
- NHS *Getting it Right First Time* recommendations published for trauma and orthopaedics, general surgery and vascular surgery

# Overview as at 9 March 2018

---

- Telephone survey completed
- On-line survey remains open (779 responses as at 9 March)
- Newspaper advertisements in weekly and daily titles across the STP – combined readership of 300,000
- Social media reach ~200,000 on Facebook – combines sponsored and organic reach
  
- Total attendance at events thus far = circa 660
- Update on events:
  - Rayleigh 7<sup>th</sup> March – estimated attendance 28 (63 booked)
  - Southend 7<sup>th</sup> March – estimated attendance 90 (126 booked)
  - South Woodham Ferrers – estimated attendance 25 (23 booked)
- Remaining events:
  - 15<sup>th</sup> March, focus group on stroke with the Stroke Association
  - 21<sup>st</sup> March, Maldon (rescheduled public event – 40 people booked)
  - 22<sup>nd</sup> March, focus group on renal with Kidney Care UK

# Independent Analysis of Consultation Feedback

---

## **Provide independent analysis organisation with:**

- All responses received (telephone, on-line, postal, social media, face-to-face, structured notes from public events and focus groups, recordings of public events and official responses from key stakeholders)

## **Report will contain:**

- Demographics (if given): Age, Gender, Ethnicity, Sexual Orientation, Marital status, Post code
- Mode of response (on-line, paper-based, letter, email, social media, telephone, face-to-face)
- Quantitative indication of support for principles (strongly agree → strongly disagree)
- Themed responses to qualitative survey questions and event face to face feedback
- Description of consultation activities and subsequent responses

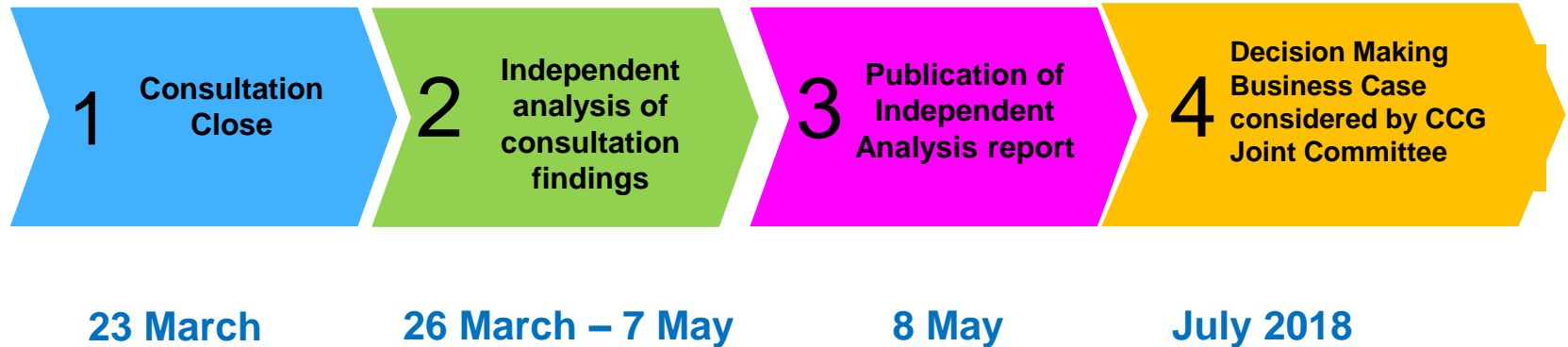

Post-consultation – review/amend proposals (as appropriate) in line with consultation feedback	May-June
CCG Joint Committee papers published	29 June
CCG Joint Committee meeting to reach final decisions	6 July
Post decision scrutiny, JHOSC response to decisions	TBC
