1. SCOPE, OBJECTIVES AND METHODOLOGY

- 1.1 In the municipal year 2009/10, the Council's Economic & Environmental Scrutiny Committee agreed that the in depth scrutiny project would be on the impact of the current economic climate¹.
- 1.2 The Scrutiny Committee agreed the project plan for the study in October 2009², with the following agreed <u>objectives:</u>
 - To understand the impact of the current challenging economic climate³ on delivering the *Total Place* agenda.
 - To make recommendations which steer the Council's response to support residents and businesses⁴ and through action have a positive effect on the community.
- 1.3 The proposed <u>outcomes</u> for the project were:
 - (a) To develop appropriate communication links to ensure residents and businesses know what services are available in terms of help, advice and support;
 - (b) That an Action Plan is agreed and implemented by relevant agencies the Action Plan to possibly include:
 - Developing a Guide;
 - Holding community events;
 - Developing a briefing pack for service providers, staff etc;
 - Running on line survey to track perception.
 - (c) The appropriate body to monitor the Action Plan, outcomes and provide feedback on progress to service providers.

Methodology/Process

1.6 During the project, the Member Project Team met on 4 occasions to drive the project forward. The Project Team drafted the questions for the three formal public evidence-giving sessions ('witness' sessions). At these sessions the Members received oral, written and presentational evidence from a number of key stakeholders.

2. BACKGROUND & CONTEXT

- 2.1 At the first witness session on 19th January 2010, the Scrutiny Committee considered and discussed a paper which provided Members with regional and local background information against which the Scrutiny Project would take place. A copy of this paper is attached in the **Annex to the Report - Document 4.**
- 2.2 At this meeting the Scrutiny Committee heard that the Council had already recognised the wide ranging impact of the recession across the Borough and has responded in a number of ways to support residents, communities and businesses alike.
- 2.3 The Local Strategic Partnership, Southend Together, was keen to act and produced a 'Recession Information Booklet' which outlines the support available from a variety of public sector organisations and initiatives from debt management to job applications and from personal support to recreation. This publication has been – and continues to be disseminated widely.

- 2.4 Insight East's (East of England Development Agency) local economic profiles provide a summary overview of the 11 upper tier local authority areas including Southend-on-Sea in the East of England. Using the most recently available statistics at the time of publishing, the profiles provides an analysis of the main economic indicators in each local authority area.
- 2.5 The March 2010 profile provides some key facts about Southend-on-Sea⁷:

<u>Population</u> - 164,300 people lived in Southend in 2008, constituting almost 3% of the East of England's population;

Economy - contributed £2,550 million Gross Value Added to the UK economy in 2007 at £15,730 per head;

<u>Enterprise and self employment</u> – there were 6,745 active enterprises at the end of 2008 – on per capita basis Southend had 507 businesses per 10,000 adults, which is in line with the East of England level and had 820 new businesses in 2008, which is 62 new firms per 10,000 adults – significantly higher than the average for the East of England and the UK; around 10,000 people of working age in Southend are self employed;

<u>Labour market</u> - as the economy entered recession in 2008, there were 65,300 jobs in Southend – the largest industry in terms of employment is public administration, education and health (34%). Other significant industries include banking, finance and insurance (25%) and distribution, hotels and restaurants (24%);

<u>Labour market – economic participation</u> - as a working age employment rate of 74% (2008-09) and 79.5% of working age people in Southend are economically active; 16 % of working age people in Southend are claiming out-of-work benefits (2009); had 5,000 job seekers allowance claimants in December 2009 which equates to 5.1% of the working age population;

Education and skills - 66% of adults have NVQ Level 2 qualification or above.

2.6 The national (world) picture about the economic climate can be found by accessing the media and also from recent reports by the Economic and Social Research Council (ESRC) and the Audit Commission⁸. The Audit Commission report outlines that the country moved back into positive gross domestic product (GDP) growth in the fourth quarter of 2009, discusses the recession as being in '2 halves' and how Councils (and

others) could respond to the economic challenge. The report also stresses the need to prepare now for leaner times ahead.

3. EVIDENCE GATHERING AND ANALYSIS

- 3.1 As mentioned in section 1 above, the questions for the witnesses were sent to them prior to their attendance at the Committee. Letters were sent to other evidence givers, inviting them to comment on the questions posed by the Committee.
- 3.2 A detailed record of general comments and specific responses to questions posed by Members of the Committee was prepared. This record of evidence was forwarded to the representative in order to ensure that the recorded evidence was factually correct.
- 3.3 The responses to the questions we asked the witnesses are detailed in the Annex to the Report Documents 1, 2 and 3. Information was also sought from a variety of written evidence givers. From both sources, the Committee was able to gain a broad picture of the impact of the current economic climate on the local economy and more widely. The possible actions which the Council could undertake to ensure that residents and businesses know what services are available and to position the town for its economic recovery were also explored.
- 3.4 All the evidence has been read and analysed. The issues raised have been grouped as follows some common themes for local issues; future opportunities / threats for development; and lessons from other areas / agencies.
- 3.5 <u>Common themes for local issues</u>:
 - > Support from the various agencies and Council appear joined up.
 - Use of the Southend Together Partnership through the recession help leaflet and community voices events were well received and identified as positive interventions.
 - Use the council publication (in our case 'Outlook') to communicate the routes to help for various segments of the 'market'.
 - There has been some significant resilience during the recessionary period across Southend.
 - Recession has been affecting people in different ways no common theme and some trends being bucked in Southend – high street.
 - In the voluntary sector there have been increases in volunteering from professional areas.
 - Working as a tier one authority in a fairly tight area has benefitted the communication process – a benefit of unitary status in evidence.
 - The expectation that there would be a surge in crime and health requirements did not materialise.
 - There has been an increase in demand for support such as business rate relief, benefit claims and advice for help.

- 3.6 <u>Future opportunities / threats for development:</u>
 - Capitalise on the major capital investments made in the last few years and underway currently to attract investment / visitors.
 - The public sector recession will hit in '12-24 months' affecting commercial and third sector with less public contracts to be offered – to prevent the effects of this work needs to be done to promote the point above and also ensure Southend remains on the radar and challenges negative perceptions.
 - Development at the airport and in particular around skills will be crucial for future success⁹.
 - Average salaries effect of increased skills and in particular around airport / advanced engineering need to be nurtured.
 - Growth of importance of Higher education / Further education sector to support high end jobs into the future.
 - Work is being undertaken by the Economic Development Team on Local Economic Assessment and a new Economic Development Strategy – both of these will need to take account of the recessionary experience and the timing from the output from the in depth scrutiny will be very important.
 - Threat of reduced resources leads to the opportunity of increased partnership working.
 - Increase the opportunities for training in manufacturing (print industry identified).
 - Initiatives such as 'Networking on sea' allow enterprises to help each other with minimal state intervention – Council funding but private sector delivery.
- 3.7 <u>Lessons from other areas / agencies:</u>
 - Develop further industry based training / Apprenticeships to equip the population with the relevant skills.
 - Wider promotion of longer staying visitors to increase spend crucial for resort destinations such as Southend and evidenced in other authorities' Strategies.
 - Tourism identified as a growth industry over the next 10 years nationally and set to overtake manufacturing – also identified as benefitting from the recession with increased domestic visitor spend and attractive overseas appeal due to exchange rate benefit.

4. CONCLUSIONS

- 4.1 The focus of the scrutiny project was in 2 parts to understand the impact of the current recession and to make recommendations which will steer the Council's response in how best to support residents and businesses so as to move forward. The project team believes that the best way to achieve this is through a joint / partnership approach.
- 4.2 From the questions and responses from witnesses, Members gained a broad picture of the current challenging economic climate and its impact. The Scrutiny Committee heard of the work already been done to support residents and businesses to have a positive effect on the community, much of it carried out under the umbrella of the Local Strategic Partnership.
- 4.3 The Project Team met on 14th April 2010 to consider the responses from all the witnesses / evidence givers and the conclusions and recommendations it wished to make to Cabinet.
- 4.4 The General Election has now of course taken place. The new coalition Government has announced its spending plans for the public sector and has identified £6.2m worth of spending cuts for 2010-2011. Local government is expected to make a contribution of £1.165bn through reductions to individual grants. Ring-fencing is also set to end for more than £1.7bn of grants given to local authorities.
- 4.5 There is obviously a need and strong imperative to 'get things right' and also of course to prepare for post recession growth. The local authority for example has already worked hard to try to minimise the impact of the squeeze on public services by improving efficiency. The *Delivering Excellence* programme is only one part of this work.
- 4.6 The full Scrutiny Committee considered and agreed the draft conclusions and recommendations at the meeting in July.

5. **RECOMMENDATIONS**

We appreciate that where recommendations may involve an increase in expenditure, this will need to be considered as part of partners budget setting process.

- 5.1 That the Council consider the in-depth scrutiny report on the economic climate and agree the conclusions from the study.
- 5.2 That Southend Together continue to develop appropriate communication links and develop a Communications Plan, to ensure residents and

businesses know what services are available in terms of help, advice and support.

- 5.3 That Southend Together develop an Action Plan detailing actions to support local people and actions to support local business for agreement and for implementation by relevant agencies. The Action Plan to include:
 - Reference to the Guide which has been developed to support residents and to keep it relevant and up to date;
 - Continue with targeted and focussed community events;
 - Through the communication plan, to develop a briefing pack for service providers, staff etc;
 - To run an on line survey to track perception.
- 5.3 That Southend Together, through the Enterprise and Community Environment Board, monitor the Action Plan, outcomes and provide feedback on progress to service providers and report back to scrutiny in 12 months.
